International Credit Union Day Giveaway 2021**

**OFFICIAL RULES**

**NO PURCHASE NECESSARY. A purchase or payment of any kind will not improve your chances of winning.**

**PROMOTION DESCRIPTION:** The International Credit Union Day Giveaway promotion ("Promotion") begins on **October 21, 2021** at 12:00:01 a.m. Central Time ("CT") and ends on **October 31, 2021** at 11:59:59 p.m. CT ("Promotion Period"). By participating in the Promotion, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of First Nebraska Credit Union ("FNCU" and/or "Sponsor"), 10655 Bedford Ave, Omaha, NE 68134, which shall be final and binding in all respects.

**ELIGIBILITY:** To be eligible, you must: 1) be a legal U.S. resident, 2) be eighteen (18) years of age or older, and 3) be a member of FNCU. **DO NOT ATTEMPT TO PARTICIPATE IN THIS PROMOTION IF YOU DO NOT MEET THESE REQUIREMENTS.** Employees, officers, and board members of Sponsor, or retailers, sales representatives, advertising and promotion agencies of Sponsor (collectively, "Promotion Entities"). Promotion is void outside of United States and where prohibited by law.

**HOW TO ENTER:** Go to [firstnebraska.org/ICUDayGiveaway](https://firstnebraska.org/ICUDayGiveaway) to enter electronically by completing the ICU Day Giveaway entry form. You may also enter by visiting any FNCU branch and completing a paper form, or by requesting an ICU Day Giveaway entry form from First Nebraska Credit Union and return it to one of the First Nebraska Credit Union branches, or mail it to: First Nebraska Credit Union, 10655 Bedford Ave, Omaha, NE 68134. Mailed entries must be postmarked on or before Oct. 30, 2021 and received by Nov. 5, 2021. All required information on the registration form must be completed to be eligible.

Limit one (1) entry per person during the Promotion Period. Duplicate entries will not be counted. Participation must be by the participant, via the ICU Day Giveaway entry form. The use of any device to automate the entry process is prohibited.

**PRIZE:** Six (6) winners, one from each branch, will be randomly selected from eligible entries and will win a Wyze Outdoor Security Camera. Need not be present to win. The winners will be chosen by a random drawing on Nov. 5, 2021 and will be notified via email and/or phone. If you are notified as a winner, you must comply with all conditions of these Official Rules and winning is contingent on fulfilling all requirements. Any potential prize winner must meet all eligibility requirements of the Sponsor. Winners may pick up their prize at the FNCU branch of their choice. Winner will have 30 days to respond to Sponsor stating they will claim their prize. If prize is unclaimed after 90 days, it will be forfeited.
