

First Nebraska Credit Union PEE WEE SAVINGS PRIZE PACKAGE GIVEAWAY

OFFICIAL RULES

NO PURCHASE NECESSARY. A purchase or payment of any kind will not improve your chances of winning.

PROMOTION DESCRIPTION: The PEE WEE SAVINGS PRIZE PACKAGE GIVEAWAY promotion ("Promotion") begins on **Dec. 20, 2020** at 12:00:01 a.m. Central Time ("CT") and ends on **Jan. 30, 2020** at 11:59:59 p.m. CT ("Promotion Period"). By participating in the Promotion, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of First Nebraska Credit Union ("FNCU" and/or "Sponsor"), 10655 Bedford Ave, Omaha, NE 68134, which shall be final and binding in all respects.

ELIGIBILITY: To be eligible, you must: 1) be a legal U.S. resident, 2) complete the Pee Wee Savings Prize Package Giveaway form during the promotion dates, and 3) have a FNCU Pee Wee Savings account, opened on or before Dec. 7, 2020. DO NOT ATTEMPT TO PARTICIPATE IN THIS PROMOTION IF YOU DO NOT MEET THESE REQUIREMENTS. Promotion is void outside of United States and where prohibited by law.

HOW TO ENTER: Go to firstnebraska.org/PeeWee-Enter to enter electronically by completing the Pee Wee Giveaway entry form. You may also enter by requesting a Pee Wee entry form from First Nebraska Credit Union and return it to one of the First Nebraska Credit Union branches, or mail it to: First Nebraska Credit Union, 10655 Bedford Ave, Omaha, NE 68134. Mailed entries must be postmarked on or before Jan. 30, 2021 and received by Feb. 6, 2020. All required information on the registration form must be completed to be eligible.

Limit one (1) entry per person during the Promotion Period. Duplicate entries will be discarded. Participation must be by the participant or participant's parent or legal guardian, via the Pee Wee Giveaway entry form.

PRIZE: One (1) "Prize Package" winner will be randomly selected from eligible entries. Prize will include merchandise valued at \$50. Need not be present to win. The winner will be chosen by a random drawing on Feb. 8, 2021 and will be notified via phone and/or email. The winner (or their guardian, if a minor) must comply with all conditions of these Official Rules and winning is contingent on fulfilling all requirements. Any potential prize winner must meet all eligibility requirements of the Sponsor. Winner (or their guardian, if a minor) may pick up their prize in Lincoln or Omaha.
